1. Due to current Buyback process of the Company by way of market purchase mode, the Listed Capital of the Company has been reduced and extinguished by 53,10,808 equity shares till June 30, 2020 and consequently Promoter and Promoter Group Holding in percentage is increased from 54.28% to 55.81%.
2. Respect Nature & Society vide PAN No. is AAQFR0389D showing in the Promoter and Promoter Group category has been dissolved with effect from April 01, 2020.
3. Pursuant to the order dated April 12, 2018, the National Company Law Tribunal approved a scheme of amalgamation and arrangement which provided for (a) merger of Ankita Pratishan Limited, Mayuka Investment Limited, Puneet Trading and Investment Company Private Limited, Zipahoad.Com Private Limited, Mahanadi Trading Private Limited and Shreevallabh Textile Private Limited with Rama Investment Company Private Limited; and (b) demerger of cement business of Keshav Power Limited and Shree Nirman Limited into Rama Investment Company Private Limited ("Scheme"). The aforesaid Scheme has been set aside by the National Company Law Appellate Tribunal ("NCLAT") by its order dated November 29, 2019 ("NCLAT Order"). Subsequently, a miscellaneous application has been filed by Rama Investment Company Private Limited with the NCLAT and the same is pending. The shareholding details of Rama Investment Company Private Limited in the shareholding pattern, has been provided basis the aforesaid Scheme.
